METHODOLOGY

EPIC • MRA, an independent survey research firm headquartered in Lansing, MI, administered live telephone interviews with 300 registered voters residing in the Hamilton Community School District from March 19th, 2021 through March 28th, 2021. The average interview length was approximately18 minutes in duration, and 50 percent of all interviews were conducted among cell phone only respondents.

The survey was designed to measure community support for a potential \$64 million bond proposal, as well to test the individual components of the proposal that could be funded should it pass after being placed on the November 2021 election ballot. The survey was also designed to test general perceptions of, and feelings toward, the District, as well as the convincingness of "arguments" both in favor, and in opposition to, the bond proposal; tested in a split sample format. That is, three arguments in support of the \$64 million proposal were read to half of the entire sample (150 respondents), after which a "vote" was taken. Following this exercise, three opposing arguments were presented, again followed by a (final) "vote". For the other half of the 150-respondent sampling, this order of presentation was reversed, in order to eliminate any potential for "presentation order" bias in the survey's results. A measurement of salience was taken for each of the respective supporting and opposing statements by asking the respondent to indicate – irrespective of how they "voted" earlier in the survey when asked – whether they found the statement to be a "Very convincing", "Somewhat convincing" or, "Not at all convincing" reason to [support/oppose] the proposal.


Respondents were included in the sample if they affirmed that they reside in the Hamilton Community School District, and *at least* "seldom" vote in November elections held in odd-numbered years or were too young to have voted before. Respondents for interviews were selected utilizing an interval method of randomly selecting records of households of registered voters who participate in elections and have commercially listed telephone landline and/or cell phone numbers. The sample was stratified so that the per-identified sub-geographies of the district (Zip Code) were represented according to its projected contribution to the upcoming November 2021 election, and quotas were further held by gender, and by age, of respondents in order to reflect the likely November 2021 electorate most accurately.

Generally, in interpreting survey results, all surveys are subject to error; that is, the results may differ from that which would have been obtained if the entire population were interviewed. The size of the sampling error depends on the total number of respondents asked a specific question. The table on the following page shows the sampling error for different percentage distributions of responses based on sample size.

For example, when asked if "overall, including all state and local funds" respondents thought that "the Hamilton Community Schools has too much, too little, or about the right amount of funding it needs to provide a quality education for its students", a 53 percent narrow majority of respondents said that Hamilton Community Schools has "about the right amount of funding" (Q.8). As indicated in the chart that follows, this percentage would have a sampling error of plus or minus 5.7 points. That means that with repeated sampling, it is very likely (95 out of every 100 times), that the percentage for the entire population would fall between 47.3 percent and 58.7 percent, hence 53 percent ±5.7 points.
