Part of this plan includes communication w/family b. **Address "compassion fatigue"**- As part of August PD, staff will be educated on this phenomenon/ strategies and a plan will be created to support each other/ checklist will be created for these meetings to support communication between all parties c. **Increasing personalization and differentiation**- each full time teacher will receive support to create a new course over the school year/checkpoints will be created during the school year/ staff meetings will include a time to support these initiatives/teachers will be trained in understanding and creating curriculum with rigour
