Boosters will continue to fundraise for the purchase and have received \$1,150 from local businesses to date. A donation website has been created, final tweaks will be made over the next few days and then the website will be shared by email and the Band's public Facebook account. All will be encouraged to share with friends/family to raise the additional funds needed.

Motion to move forward with the purchase of the raincoats using existing funds and funds from the school (in the amount of approx. \$14,000) and to continue to fundraise to replace funds spent was made by Charity, support by Amity. All attendees approved the motion.

Director's Report

Discussion was held on the rate we pay our accompanist per event. Current rate is \$35 which is lower than the comparable schools payment of \$50 per event. Motion made by Jeff to increase the amount paid per event from \$35 to \$50 for accompanists, Charity supported. All attendees approved the motion.
